Swing-Out Seat — For those who have difficulty entering and exiting a vehicle, a swing-out power seat is available which provides assistance to the front passenger.







Commercial Para Transit - In addition to vehicles for personal automobility, Dodge can also provide vans and wagons suitable for commercial para transit applications. These vehicles meet or exceed all applicable American Disability Act standards.

Side Door — The side-mounted lift in a van is the most practical use of space, especially for the driver. The rear bench seat and front passenger seat may be retained. Several different lifts and ramps can be installed to meet a variety of needs for vans that will transport one or more passengers.

Rear Door — Rear-mounted lifts are used for wheelchair loading access to the rear of the van, with the middle seat left in place for an ambulatory passenger. Rear lifts can be equipped with power door operation and a remote control.





Adaptive Controls – Reduced-effort to zero-effort steering, brake and accelerator controls can be custom-fitted to the range and motion requirements of the operator.

an assistance program — years

Here's a brief description of how the current program works:

When you buy or lease a new Dodge van, wagon or minivan and have adaptive driving or passenger equipment installed on the vehicle, Chrysler Corporation will give you a cash reimbursement to help cover the cost.\* Conversions to full-size Ram Vans and Ram Wagons may be reimbursed up to a maximum of

\$1,000 and all other cars, trucks and minivans up to a maximum of \$750. This is in addition to any other applicable Chrysler Corporation cash incentive programs in effect at the time of purchase or lease or any additional outside funding you may secure. For example, commercial van and wagon buyers may receive a choice of either a \$500 cash incentive or a 5-Year/100,000-Mile Power Train Service Contract.† Call 1-800-WORK RAM to obtain a certificate. Remember that all rebate and incentive programs have expiration dates and eligibility requirements. Contact your dealer for complete details.

To help you finance the cost of your new van, or modifications for

adaptive equipment, complete Chrysler Credit financing is available to qualified new vehicle buyers.

Program Headquarters can help you identify and locate local driver assessment centers and adaptive equipment dealers and installers. We can also advise you on which Dodge van or other Chrysler Corporation vehicle can be adapted for your needs and answer any other questions you have about the program.

\*Adaptive equipment is defined as equipment needed by a physically challenged person to drive, enter, exit and be transported safely in a motor vehicle. Factory optional equipment does not qualify for reimbursement.
